

## Earth's Edge Christmas Offer 2024 - Terms & Conditions

The Earth's Edge Christmas Offer 2024 (the "Competition") is organised by Earth's Edge Ltd. (the "Promoters") and subject to the following Terms & Conditions.

### **1. Eligibility**

- The competition is open to individuals aged 18 years or over, excluding employees of the Promoters or anyone professionally connected with the promotion.
- Entry is open globally; however, if a prize is a physical product, shipping is only included within the Republic of Ireland and the United Kingdom. International winners may be responsible for any additional shipping charges and import duties.
- Prizes that include alcohol will only be awarded to winners of legal drinking age in their jurisdiction. Proof of age may be required. If a winner cannot accept an alcohol-related prize due to local laws or age restrictions, an alternative prize may be offered where possible.

### **2. Competition Period**

- The competition will run from 00:01 on 1st December 2024 to 23:59 on 31st December 2024 at 23:59 (Irish Standard Time - IST).
- Entrants outside of this timezone are responsible for ensuring their entries align with the stated competition period.

### **3. Entry Requirements**

- To qualify for the competition, entrants must make a new booking on earths-edge.com by paying the relevant booking deposit for any available expedition and date during the competition period. Each new booking automatically qualifies as a separate entry, allowing participants to enter multiple times with additional bookings.
- By participating, entrants acknowledge and accept Earth's Edge's standard [booking conditions](#) as they apply to any expedition booked.
- Bookings cancelled or refunded before the prize drawing date will be disqualified from the competition.
- Only brand-new bookings completed between 00:01 on 1st December 2024 and 23:59 on 31st December 2024 will qualify for entry. Bookings made outside this period, even if transferred during December, will not be eligible.

### **4. Withdrawal of Entry**

- Entrants may withdraw from the competition by contacting the Promoters directly via [support@earths-edge.com](mailto:support@earths-edge.com). Withdrawing from the competition will not affect the booking itself or any of Earth's Edge's standard booking conditions.

### **5. Entrant Conduct**

- If the Promoters find any entrant to have acted in bad faith concerning the competition, the entrant will be disqualified and deemed ineligible to win. Examples of bad faith include, but are not limited to, providing false information, attempting to manipulate the outcome, or failing to comply with the competition rules.

## **6. Competition Changes**

- The Promoters reserve the right to alter, withdraw or terminate the competition and/or its Terms & Conditions at any time and without prior notice.

## **7. Prize Allocation**

- The grand prize winner will be selected by a random draw, which will take place on 6th January 2025 from all eligible entries received during the competition period.
- Winners for the additional prizes will be selected from eligible entries through random draws held periodically throughout December 2024.
- Decisions made by the Promoters regarding prize allocation are final and not open to appeal. No correspondence will be entered into regarding these decisions.

## **8. Winner Verification**

- The Promoters reserve the right to verify the identity of winners before awarding prizes, including requesting proof of booking and identity. Failure to provide satisfactory proof may result in disqualification.

## **9. Prize Notification and Claim Period**

- Winners will be notified via email within 14 days of the competition closing date.
- Winners must respond to the Promoters within 30 days of receiving their prize notification to claim their prize. The Promoters reserve the right to redistribute a prize if they are unable to contact the winner(s) or if the prize remains unclaimed by 14th February 2025.

## **10. Prizes**

- **Grand Prize:** One free Earth's Edge Expedition, including return economy flights from Dublin as part of the group's flight itinerary, and all other inclusions listed on the relevant expedition information pack only. The winner will have their paid booking deposit refunded.
  - The destination, itinerary, and flights of the expedition are fixed and cannot be changed. Any additional travel or modifications will be at the winner's expense. No refunds or exchanges are provided for unused portions of the prize.

## **13. Promotional Use of Winner's Information**

- By entering the competition, entrants consent to the Promoters using their name, image, and likeness for promotional purposes on their website and social media channels if selected as a winner.
- Winners can withdraw their consent for promotional use of their name, image, or likeness at any time by contacting the Promoters. However, this will not affect any promotions already published.

## **14. Privacy and Marketing Communications**

- Entrants' data will be handled per Earth's Edge Privacy Policy and relevant laws, including the EU General Data Protection Regulation (GDPR), used solely for competition purposes unless further consent is provided. By entering, entrants agree to receive emails about the competition. Entrants can unsubscribe at any time.

## **15. Governing Law**

- These Terms & Conditions and any disputes arising from them shall be governed by and construed in accordance with Irish law, with disputes falling under the exclusive jurisdiction of the Irish courts.

## **16. Acceptance of Terms**

- Participation implies acceptance of these Terms & Conditions.
